## 4. Policing

- 4.1 Safer Neighbourhood Team Report
  - Aladdins Cave of unidentified items will be held Brent Town Hall, Sat 13<sup>th</sup>.
  - Burglary increase to 8.(Buller & Pember) On edge of burglary zone spreading from College Road. (Mon & Wed at 4pm) Member noted Berens Road has put in request for Smartwater but needs min. 6% take up in street to initiate.
  - Request Police check if any correlation betw. Burglaries and dustbins left outside on pavement.
  - Recommend manual operated CCTV on Chamberlyne Road down to Kilburn Lane – raise at next meeting with local Cllrs.
  - Motor vehicles downward trend Cresswell Carpets have been helpful in notifying police of abandoned motor bikes in back yard.
  - · Residents should report damage to vehicles as well as theft.

- 5.2 Kensal Green/Rise Bridges

Harry True – Chairman Kensal Rise Business Association, QPRA liaison on Neighbourhood Working Fund. Propose extend QPR plans to upgrade QPR railway bridge to include bridges in KR/QP area with following proposal:-

- Pressed steel enamel signs 1-1.5" thick.
- Funding from Brent Council, NW Fund but bridges owned by Railtrack, got bogged down in bureaucracy.
- Simplicity is key easy to mount & de-mount for bridge maintenance.
- Persuade Emily & other councilors to dedicate money from NWfund. Approx cost 6,050 GBP supplied & fitted.
- Rail Track need to approve
- Phil –proposed KTRA write letter of approval & form committee with representatives from Elliston Park Residents Association, KTRA and Harry True.
- Design should be open to tender to local Professionals
- Committee to select/approve 'Best of 3' designs then put on display for public vote
- Unanimous agreement no children's designs.
- KTRA should be consulted on design process need to agree timeline
- Design brief part of urban renewal/ bridges are on edge of conservation area
- Harry asked if conservation area can be extended to include Kilburn Lane?
