Safer Neighbourhoods:

The Community Support Officer Ollie Pearson Wright reported that, since the last meeting, there had been

- 2 burglaries
- 1 robbery (after carnival)
- 4 cars broken into.

The CSO stressed that residents can do a lot to deter crime e.g.

- ensuring that all windows are locked when leaving home (or asleep)
- ensuring that no items are left in view in a vehicle. In addition to removing sat-nav units, it is important to remove the holder and to wipe the windscreen as the holder can leave marks that can be detected by a would be thief.

The Safer Neighbourhood Team will be conducting an Environmental Visual Audit (EVA) of the Triangle to log graffiti, litter, damaged planting, etc. They will then liaise with L B Brent to rectify the situation. Update to be provided at next meeting.

Proposed meeting with Queens Park Residents Assoc and College Rd Residents Assoc

Sgt. Pilkington had proposed that representatives from the three groups meet to identify any common issues. The meeting suggested that issues could include:

- Planning issues on the border of each area that would affect residents in the neighbouring area
- The need for safety camera's on the towpath by Sainsbury's
- Harrow Rd Traffic Crossings.
- Litter and lack of cycle parking at Kensal Green Station
- Parking congestion on the Harrow Rd at College Park shops.

Article on speed calming for Queens Park Labour Party newsletter

Avril outlined the article and noted that it would help to publicise the work of the Residents Association. The meeting agreed this was a good idea.

Monumental Masons/Grants: Bid for 'listed' status.

Jude reported that she had spoken to English Heritage, who have visited the site and met the Developers. Apparently the Officer has prepared a report on whether the building should be listed, but the report has to be signed off before it goes to Department of Culture, Museums and Science (DCMS). If the DCMS agrees to spot-listing then the process will take at least a further week. Under pressure from Jude the officer agreed we had a good case, but he flatly refused to indicate whether he thought we would be successful.

Member expressed concern that the internal timbers, that are a major feature of the Grants building, may have already been removed. No one in the meeting was able to confirm or deny this

Members also discussed the wall-mounted memorial in the entrance of Farrells. Apparently this was the plaster model of the 6th Earl Poulett (the finished marble item is in St George's, Hinton St George, Somerset) Some discussion as to whether, in the event of demolition, this could be rescued and housed in the Cemetery. Noted that the Friends of the Cemetery manage the Dissenters Chapel and may be able to help.

Development of Land next to 864 Harrow Rd (i.e. next to the petrol station)

The meeting was told that members of the KGRA had recently attend the Planning Meeting. The general view was that the proposed building was an appropriate size and that the building and garden would be attractive. The main concern was that finish to the front of the building would not be in keeping with the neighbouring properties. Though the Planning Committee ignored the concerns, and agreed Permission with condition, the architect contacted KGRA members after the meeting and assured them that the building would be faced with brick up to the second floor, with timbering only on the top floor which would be set back.

Noted that, in line with Brent policy the residents will not be allowed to apply for parking permits, and that there is no parking on the site.

Development rear of 30 Chamberlain Rd (r/o shop on corner of Wakeman Rd)

A resident had queried this as he was concerned that he flat roof and pvc porch was out of keeping with the neighbourhood.

L B Brent Planners have agreed to visit. Apparently the original permission was given in 2002.

Harrow Rd Speed Cameras

Hurrah! Brent have agreed and the camera for the Brent side of the road should be fitted in 6 - 8 weeks.

Cllr Moylon, Deputy Leader, Royal Borough Kensington and Chelsea, in spite of agreeing to a camera 'in principle' at a meeting with Transport for London, still wants to delay the final decision for a camera on the RBKC side until he has seen the results of the Brent Camera. A letter urging a quicker decision has been sent to Cllr Moylon, copied to the Mayor of London, TfL, Police, London Assembly member, Brent Councillors.

A separate letter has also been sent to the Mayor, highlighting key issues and asking for his help (also copied to other parties)0
